[Note: If there will be further citations to a work, add the author's last name in square brackets. If there are also citations to a different work by the same author, add the short form of the title of the source in the square brackets as well.]

#### **Citations to earlier citations:**

Europa World Year Book, ibid at 4244. [to direct the reader to the immediately preceding endnote, whether or not it is the full citation – i.e. it can be used after a supra, or another ibid]

Gadamer, supra note 3. [to direct the reader to the full citation if it is not immediately preceding]

# Cases, Constitutions, Statutes, Treaties, and other primary legal sources:

- For general questions about English- or French-language citations, consult McGill Law Journal's *Canadian Guide to Uniform Legal Citation*, 8th ed.
- For court cases, *cite paragraph numbers rather than page numbers wherever possible*. Include a neutral citation (if available):

Chaoulli v Quebec (Attorney General), 2005 SCC 35 at para 5, [2005] 1 SCR 791 [Chaoulli].

- Except as part of a case citation in a footnote, refer to judges as, for example, "Chief Justice McLachlin" rather than "McLachlin CJC."
- If a document (treaty, statute, etc.) is a main focus of your article, it may be useful to include a citation to a free electronic source for it (if available), in addition to the full legal citation.
